KNOW THE COMPLIANCE LANDSCAPE AND HOW ITS CHANGES

What to do: Build an internal compliance review process or work with a partner who monitors regulatory changes in real time and updates documentation workflows proactively.

It's not enough to get freight moving. You need to know where it is, who's handling it, and what could delay it. Especially with rising cargo theft and congestion, real-time tracking is now an operational standard.

What to do: Invest in systems that provide full shipment visibility or partner with a provider offering real-time traceability and proactive exception alerts.

TREAT THE BORDER LIKE A LAYER, NOT A LINE

Many companies approach the border as a simple transfer point. In reality, it's a high-friction zone requiring detailed planning, skilled coordination, and careful partner selection.

What to do: Ensure your teams or providers have deep experience managing customs, transloading, cross-dock handoffs, and bi-national communication. Your teams and providers should have people on the ground that understand the ever-changing landscape.

PREPARE FOR NEARSHORING AT SCALE

With more companies shifting manufacturing to Mexico, logistics operations are under pressure to keep up. But expanding into Mexico requires more than finding a new carrier. To be successful, it's about building infrastructure.

What to do: Plan for warehousing, WMS/TMS deployment, workforce needs, and systems integration from the beginning. Look for partners who can help you operationalize quickly.
